### **CRITERIA FOR ASSESSORS:**

**The Board of Nursing approved the following criteria of assessors:**

- 1) Should be an expert in the field, e.g., and addictionologist, clinical psychologist or have a minimum of a master's level in counseling, psychology or social work and a minimum of five years work experience in the field of chemical dependency.
- 2) Assessor needs to have an understanding of public policy and safety issues, and understand how to function performing assessments for third party referrals.
- 3) Be willing to consult with nurses not only regarding the nursing field, but also the setting, to gain appreciation of the elements, potential risk and the ethical implications of the situation.
- 4) Willing to broaden sources for evaluation and collateral information such as conduct telephone interviews with employers, coworkers, and family members.
- 5) Willing to review accounts of the allegation.
- 6) References from credible sources.
- 7) Willing to utilize multiple assessment tools including but not limited to: bio-social interview, SASSI 4 DSM V Criteria.
- 8) Demonstrated skill in evaluating or treating sophisticated professional clients.
- 9) Willing to make a clear diagnosis, or an explanation of the lack of diagnosis.
